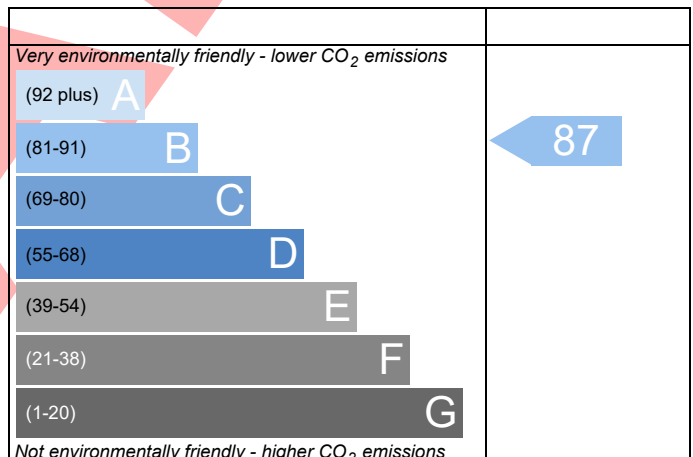
## Energy Efficiency Rating
